#### **Hospital Parking Directive Requirements:**

As per the Hospital Parking Directive, Hospital parking rates as directed by the province of Ontario are frozen and can only increase at the rate of inflation. Hospitals are also required to offer five-day, ten – day and 30-day passes with a discounted rate

#### **Hospital Parking Directive Findings:**

Per communication with Paul Greenwood, Director Security & Fire Safety, parking rates at Unity Health Toronto at all three sites remain unchanged from the prior year and parking passes at a discounted rate are available. Please refer to **Appendix A** for a listing of the parking rates at Unity Health Toronto. In addition, there are no known material exceptions to the attestation.

### **Hospital Parking Directive Recommendation and Action:**
